Proclamation of Peace and Request for liaison officer

Dear Captain Kerr,

You will note this letter was sent to you early November 2024, this is now the second letter as a way of formal notice for proclamation of Peace and request for a liaison officer.

Please also note, a copy of this Proclamation of Peace and Request has been forwarded onto the American Ambassador in Australia Caroline Kennedy as well as The Re elected President Donald Trump.

Regarding: This letter serves to introduce The Freedom Union, a Private Members Union, formed to comply with the Rome Statute article 25.3(f) to carry on trade and utilising the doctrine of necessity.

We serve this formal Notice as our Proclamation of Peace, requesting a liaison officer to mediate between our trade Union and the Labor Union run by Anthony Albanese for domestic trade.

We are aware that Australia is currently under military command and operating under military law and as such advise, as hors de combat and as an emerging State, that we come in peace and exercise our basic human right to assemble and hold the Australian leaders to their obligations under the Rome Statute expressly article 25.3(f).

These facts, conclusively, display an apparent course of action wherein our members, have been and are being dangerously and without regard for international law, abandoned and subjected to lawlessness. The members of our Union have taken measures to comply with the Rome Statute and as it is our duty to cease all forms of trade where humanly possible with the Australian Labor Party. Members of the Union are in genuine fear for their personal safety and give cause to further note;

Law of Nations, Book 1, §220. Whether a person may quit his country.

"...as all persons may quit their country, as they have a right to enter into the society of which their fathers were members. But every man is born free; and the son of a citizen, when come to the years of discretion, may examine whether it be convenient for him to join the society for which he was destined by his birth. If he does not find it advantageous to remain in it, he is at liberty to quit it" and Law of Nations, Book 1, §202. Their right when they are abandoned:

"The state is obliged to defend and preserve all its members (§17); and the prince owes the same assistance to his subjects. If, therefore, the state or the prince refuses or neglects to succour a body of people who are exposed to imminent danger, the latter, being thus abandoned, become perfectly free to provide for their own safety and preservation in whatever manner they find most convenient, without paying the least regard to those who, by abandoning them, have been the first to fail in their duty."

According to General Assembly resolution 3166 (XXVIII) of 14 December 1973 Annexed Convention, Point 4
"Recognises also that the provisions of the annexed Convention could not in any way prejudice the exercise of the legitimate right to self-determination and independence, in accordance with the purposes and principles of the Charter of the United Nations and the Declaration on Principles of International Law concerning Friendly Relations and Cooperation among States in accordance with the Charter of the United Nations, by peoples struggling against colonialism, alien domination, foreign occupation, racial discrimination and apartheid."

We draw your attention to UN General Assembly resolution 2200A (XXI) International Covenant on Civil and Political Rights adopted 16 December 1966 which states in Article 1, Point 3: "The States Parties to the present Covenant, including those having responsibility for the administration of Non-Self-Governing and Trust Territories, shall promote the realisation of the right of self-determination, and shall respect that right, in conformity with the provisions of the Charter of the United Nations.

We respectfully request that in accordance with the treaties, conventions, covenants and other instruments of international law, the Corporation known as the Commonwealth of Australia support and promote Self-determination for the new state "The Freedom Union".

In accordance with The Declaration on the Right and Responsibility of Individuals, Groups and Organs of Society to Promote and Protect Universally Recognised Human Rights and Fundamental Freedoms Article 6 which states:

"Everyone has the right, individually and in association with others:

To know, seek, obtain, receive and hold information about all human rights and fundamental freedoms, including having access to information as to how those rights and freedoms are given effect in domestic legislative, judicial or administrative systems;

As provided for in human rights and other applicable international instruments, freely to publish, impart or disseminate to others views, information and knowledge on all human rights and fundamental freedoms;"

We now request that the military, in accordance with Jags Text and International Law, nominate a designated liaison officer to assist in any matters arising as hors de combat and as an emerging State under Self-Determination. We seek for a peaceful transition with the Australian Federal Government as they fulfil their international law obligations to support and promote our new state of being.

We look forward to your prompt response.
