Letter of introduction and Request for assistance

Dear President Donald J Trump,

Introduction

I would like to take this opportunity to introduce myself and The Freedom Union to you. The Freedom Union has been recently launched here on the continent of Australia in response to the War Crimes being engaged in by the Albanese government and the Australian parliamentary. The Freedom Union has also been launched in response to the widespread and deep corruption that has taken root within all of the Workplace Relations Act registered trade unions.

Who we are

The Freedom Unions national launch was necessitated after two things were discovered

1. National Strike Australia uncovered that the Albanese government and all its governmental subsidiaries and third-party agencies are in fact non constitutional and unlawful. I would draw your attention to the published works of the Australian researcher and author Dick Yardley and in particular Australian political treason treachery & sabotage.
2. On the fourth of March 2024 the national Australian law firm Birchgrove Legal filed a Case for Complicity to Genocide to the Hague - International Criminal Court. It is now a matter of fact that the Australian Prime Minister Anthony Albanese has been referred to the International Criminal Court as an accessory to genocide in Gaza, making him the first leader of a Western nation to be referred to the ICC under Article 15 of the Rome Statute.

Actions in progress

Thus far in response to those two discoveries the following actions have been taken.

1. A new trade union has been launched 'The Freedom Union' who have used the appropriate international laws 'Freedom of Association' to establish its lawful standing.

3. Thus far it is evident and clear that ongoing War Crimes are being committed against members of The Freedom Union in Australia. In response The Freedom Union of Australia is preparing evidence and official lodgement of War Crime Incidents committed against our union members to be lodged with The Office of the Prosecutor with the International Criminal Court (ICC). So that prosecutions can commence.

Concerns held

1. We have not received any response to the first Provost Marshal letter send early November 2024 (copy attached).
2. The Albanese government and all its governmental subsidiaries and third-party agencies are ignoring and will continue to ignore their obligation under international law and will continue to commit and engage in War Crimes.
3. Also of deep concern is the targeting of those Union members who have and will lodge Incidents with the International Criminal Court despite having witness protections and it being a duty of care of an international citizen to not be complicate in War Crimes i.e. funding an aggressor in times of war.

Request for Assistance

President Trump, given the actions taken by The Freedom Union and its members to completely disassociate ourselves from the War Crimes being committed by the Albanese government and all its governmental subsidiaries and third party agencies. I call upon you for assistance and support by taking the following steps that would enable and encourage appropriate international law to be applied and honoured.

- a) Can you please contact all recipients of the Provost Marshal letter, see attached, demanding that they discharge their duties and obligations that they have under international law to The Freedom Union and its members.
- b) Can you please contact the International Criminal Court and make them aware of the War Crimes being committed against the members of The Freedom Union by the Albanese government and all its governmental subsidiaries and third-party agencies and urge them to expedite prosecutions against these War Criminals.
- c) Could you please contact the International Court of Justice and draw their attention to the War Crimes being committed.
- d) Could you please contact the United National Security Council and forewarn them that there is a possible rogue nation state operating on the mainland of Australia in the capacity of a belligerent occupation. Could you please contact the Chairperson (Russia) set up formal communication for The Freedom Union.

I look forward to your prompt response.
