Pledge

I, of my own free will in good faith with the legal capacity to contract, hereby enter into this private membership agreement with The Freedom Union, and agree to join and pay the annual membership fee of \$200.

And, I also agree to The Freedom Union's constituting Articles and its bylaws, and when amended or are passed as adopted to benefit myself as an ordinary member and I mutually and collectively agree to the;

Non-Disclosure Agreement

I fully understand that any information that is obtained and/or learned is under non-disclosure in accordance with the bylaws of the Union and the business is private and not to be shared outside of the Union without written consent of the Assembly Board of Trustees.

I affirm that no private information may be sequestered or a member questioned or coerced by any outside agency or public court to obtain information in the aforementioned Private Membership Union, and agree to the;

Voluntary Disclosure

In the event that information is voluntarily disclosed to a non-member (i.e any foreign belligerent occupying military government), I hereby agree to pay the trustee a \$100,000. Penal sum, as a fee for the breach of the privacy and information disclosure.

Security

I affirm that I am not acting as an agent or policy enforcement arm of any other foreign body corporate, company, corporation, state or government body or in any capacity officially for any City, State, Union or Federal agency or any member of any secret society in an attempt to investigate or sequester the private information of The Freedom Union or its members.

But I only make application for membership solely to seek safe harbour and peaceful enjoyment so that I may enjoy the social benefits as I assemble with members of a like state of mind in a new state of being (The Freedom Union).

Membership

Card and conditions or restrictions of use must be observed at all times. If a member has completed a safety course for the operation of a motorised vehicle, firearm or to operate heavy or light machinery, or the like, then the bylaws must be fully observed, and if the member does not commit any nefarious acts or carries on any substantive evil that may reflect negatively on the The Freedom Union or its member then it shall be deemed that no breaches have occurred as long as responsibility has been taken for the safety of all members. A card replacement service charge will consist of \$50.00 to satisfy the replacement by a service provider. I agree to the fee as a new member of The Freedom Union.

Code of Conduct

I will extend kindness to all others, act honourably even when confronted with controversy or conflict and will assist or take action to help a member in need if I am capable of relieving the situation and take all measures to assist and I will pledge to respect a differing opinion by a fellow member and not push their acceptance of my alternative opinion but take measures to go in peace where available.

Conduct in Difficult Situations

In a violent situation, I will only defend myself with equal measure until assistance is provided, if I am unable to call for assistance, I will attempt to de-escalate the situation regarding any disagreement if it turns into an argument I will walk away from the situation.
